Thank you for being part of a movement committed to protecting our beautiful countryside for everyone. I've popped your membership card in with this letter.

I hope your organisation is proud to be a member of CPRE, the countryside charity - together we've achieved many important successes over the past 12 months. Here are just some of the campaign wins we've achieved together recently:

- In collaboration with a broad coalition across the sector, we ensured that a new type of national planning policy introduced in the Levelling Up and Regeneration Act would require public consultation as standard. Initial drafting of this legislation would have given the Secretary of State carte-blanche power to create and modify planning rules - covering green belt to housing - at their own discretion.
- By lobbying the government, we influenced the confirmation of a new funding scheme to pay farmers to plant more hedgerows and manage them sustainably.
- We've recruited 34 parliamentary champions for rooftop solar who are helping us lobby the government for more action to get solar panels on top of buildings, cutting carbon emissions and protecting valuable greenspace for nature and farming.
